## 4.1. Description of first aid measures

- General** : In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and seek medical advice.

There are no data available on the mixture itself. The mixture has been assessed following the conventional method of the CLP Regulation (EC) No 1272/2008 and is classified for toxicological properties accordingly. See Sections 2 and 3 for details.

Exposure to component solvent vapour concentrations in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system. Symptoms and signs include headache, dizziness, fatigue, muscular weakness, drowsiness and, in extreme cases, loss of consciousness.

- 7.1 Precautions for safe handling** : Prevent the creation of flammable or explosive concentrations of vapours in air and avoid vapour concentrations higher than the occupational exposure limits. Electrical equipment should be protected to the appropriate standard. Mixture may charge electrostatically: always use earthing leads when transferring from one container to another. **8.2 Exposure controls**

Where possible wet sanding or chemical stripping methods should be used with surfaces of this type to avoid the creation of dust. All scrapings, dust, etc. should be disposed of by the professional painting contractor as Hazardous Waste.

Extra precautions will also need to be taken when burning off old lead-based paints because fumes containing lead will be produced. It is recommended that a respirator, approved for use with particulate fumes of lead is selected on the basis of the COSHH assessment, taking into account the Workplace Exposure Limit for lead in air.
